### Administrator's Statement

86th Regular Session, Agency Submission, Version 1 Automated Budget and Evaluation System of Texas (ABEST)

### 998 Northeast Texas Community College

Northeast Texas Community College supports the \$1.9 billion consolidated formula funding request by the Texas Association of Community Colleges as set forth in the July 24, 2018 letter. With additional support from the state of Texas, Northeast Texas community College will:

- Continue to expand our award-winning CTE/Dual Credit center in Mt Pleasant to support regional workforce programs vital to our local economy.
- Increase the number of high-demand health science dual-credit programs to include more of our rural area ISD's.
- Expand nursing programs to include a night Associate Degree Nursing cohort.
- Add additional student support personnel and career counseling staff in support of the Texas "Guided Pathways" project to improve high school -to-community college and four-year college transfer and completion rates.
- Further expand our innovative work scholarship program, which provides students with meaningful work at above-market wages, and allows them to complete a community college degree without student loan debt. This program is uniquely designed to address the cost of attendance while also preparing "work-ready" students who will have a valuable work history to add to their educational credentials upon graduation.

### SIGNIFICANT CHANGES IN POLICY:

There are no significant changes in policy which impact this budget.

### SIGNIFICANT CHANGES IN PROVISION OF SERVICE:

There are no significant changes in provision of service which impact this budget.

### SIGNIFICANT EXTERNALITIES:

Luminant, once the largest assessed taxable valuation for the college, has shut down their Monticello plant given various challenges facing the profitability of that particular operation. In addition, Luminant has protested the Titus County Appraisal District's assessment for tax years 2015 through 2018. Luminant contends that its taxable assessed value for the plant should be \$0 for the 2018 taxable year. Over the past 4 years, Northeast Texas Community College has lost an average of a little over \$240 million per year in taxable valuation, or 9% of our tax base.

Background checks are conducted on all security-sensitive positions as permitted by the Texas Government Code, Sec. 411.094 and Texas Education Code, Section 61.003 (8), and consistent with the college's human resources policies and procedures.

Northeast Texas Community College's Campus is located approximately six miles southeast of Mt. Pleasant, Titus County, Texas. Classes are offered at alternate sites in Camp, Morris, Franklin, Red River, Titus, Upshur, and Wood Counties. The College provides associate, vocational, and continuing education courses.

### ORGANIZATION OF COLLEGE

Northeast Texas Community College District was established as a public community college in an election held in Camp, Morris and Titus Counties, in 1984. The District operates as a community college district under the laws of the State of Texas. The District is governed by a seven-member Board of Trustees elected at-large by place. The Northeast Texas Community College Board of Trustees as of July, 2018 includes the following:


