

## **CARES Act – Student Portion Fund 45-day Report**

1. **NTCC** acknowledges that the College has signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
2. **\$570,137** is the total amount of funds that NTCC has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students.
3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter). **\$321,250**
4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act. **1,062**
5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act. **1,062**

**Students must have been enrolled in at least on face to face class in the spring and,**

**Student must:**

- **Be enrolled or accepted for enrollment in a degree, certificate, or other eligible program**
- **Have earned a high school diploma or GED**
- **Maintaining satisfactory academic progress**
- **Not owe a refund on grants previously received**
- **Submit statement of educational purpose**
- **Submit social security number - (school shall verify any social security number provided by a student)**

- **Be a citizen of US or eligible noncitizen - (shall be verified prior to the individual's receipt of a grant)**
- **Register with Selective Service, if required to do so - (confirmation required)**
- **If convicted of a crime involving fraud in obtaining T4 funds, have completed the repayment of such funds**

**Student must not:**

- **Have borrowed in violation of the annual or aggregate loan limits**
- **Have previously received a baccalaureate or professional degree**
- **Have been convicted of any offense under any Federal or State law involving the possession or sale of a controlled substance for conduct that occurred during a period of enrollment for which the student was receiving any T4 aid**

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

**Students that received money have been sent a letter in the mail explaining the reason for the payment. Students that could qualify, but were not readily verified during the initial stages, are being contacted and will be provided a certification form to verify eligibility.**
