Cosmetology Operator Program Application Packet**

Thank you for your interest in the Cosmetology Operator Program at Northeast Texas Community College. The Cosmetology Department at NTCC is licensed by the Texas Department of Licensing and Regulation. Acceptance to this program is based on criteria which have been enclosed in this enrollment/information packet. Students are accepted per approval on a first come first serve basis, so returning your packet & deposit as early as possible is the best way to ensure your acceptance into the program. Once the maximum class size is reached, the class is closed until the next fall semester enrollment. Enrollment packets are not accepted if they are not complete, are missing documents, or the required deposit is not included.

Even though NTCC has an open-door policy, the Cosmetology Operator Program must limit their enrollment due to limited lab space and available clinical facilities. Minimum academic standards will be set. If the applicant does not meet the minimum requirements of the admission criteria, the student may be directed to seek advisement in help with achieving requirements or setting other career goals. Any information that is misrepresented or falsified may result in denial of admission and expulsion from the Cosmetology Program.

Application Packets may be submitted **in person** to the Cosmetology Department on the NTCC Campus which is located in the Business Technology Building (M-Th, 8am-3pm), or mailed in to the address below. If you plan to mail your packet in, PLEASE EMAIL OUR DEPARTMENT to let us know it is being mailed. A mailed-in packet would need to have a check or money order included for the \$200 deposit in order to be considered complete, along with all other required items (see list on next page).

**Checklist for Enrollment - Submit the Following Items to the Cosmetology Dept to be considered:**

\_\_\_\_\_ 1. **This application packet**, complete with all pages filled out legibly & correctly. This should be completed by the prospective student ONLY (not by parents/friends, etc.).

\_\_\_\_\_ 2. **\$200 Non-Refundable Deposit** (cash, check, money order or credit card) Please submit this with your packet.

*Please remember this \$200 deposit is required and non-refundable. In the event the student decides to withdraw from the program after the class has started, there will be no refund of the deposit. Deposits are given back to the student upon successful completion and graduation of the Cosmetology Program.*

\_\_\_\_\_ 3. **One (1) letter of Recommendation**. This letter should be written by someone who knows you well, who can speak to your character and work ethic. This might be a former teacher, pastor, counselor or mentor. This would be in the same format/context as a letter of recommendation that would be included with a job application. Please submit this with your packet.

\_\_\_\_\_ 4. **Student Essay**. Student's should type a (minimum) 1-page essay and explain your interest in the field of Cosmetology. You may comment on previous experiences which may be work related or personal, and/or hobbies that may have influenced your decision to enter the field of Cosmetology. You may also include ideas about how obtaining your Cosmetology operator license may affect your future career plans. This should be completed by the prospective student ONLY (not by parents/friends, etc.). Bring this in with your packet.

\_\_\_\_\_ 5. **NTCC Admissions Application**– Students are required to do an NTCC admissions application and have a valid NTCC student ID number before submitting a Cosmetology Application so that they can be enrolled in Cosmetology classes.

\_\_\_\_\_ 6. **FAFSA/Financial Aid Application** – Although not required, we do suggest students submit a financial aid application. Payment for tuition, fees, and books/kit/uniform for the Cosmetology Program must be taken care of BEFORE the first day of class in order to attend. We recommend all students complete a FAFSA application (done online, via our website also) in case they may qualify for financial aid. NTCC also offers payment plans and/or scholarships for students who meet minimum requirements. No matter how you plan to pay for your courses and materials, it is MOST important that you have a PLAN in place.

## Essential Job Functions Form

The following are essential job functions for any Cosmetologist/stylist/operator student or Professional in the industry, as compiled from observations of a wide variety of job/salon experience:

1. VISUAL ACUITY:
  - Maintain a minimum standard of visual acuity required to observe a client's facial shape, hair condition, and or abnormal or unusual condition which may prevent Cosmetology services.
  - Maintain a minimum standard of visual acuity for operation of implements and equipment.
  - Maintain a minimum standard of visual acuity for visual inspection of the necessary sanitation requirements pertinent to the Cosmetology environment, use of computer terminals, extensive reading, and using measurement.
  
2. HEARING ACUITY:
  - Perceive the nature of sound and receive and interpret detailed information through oral communication.
  - Hear and respond to instruction, and client information and needs.
  - Hear and retain pertinent information necessary for success in the Cosmetology industry.
  
3. COMMUNICATION ABILITY
  - Express, exchange or interpret ideas by means of the spoken or written word, accurately, loudly, and quickly as necessary.
  - Communicate sufficiently nonverbally, in reading and writing to appropriately interact with individuals and to communicate their needs promptly and effectively for the client's best interest.
  
4. DIGITAL DEXTERITY
  - Move the wrists, hands, or fingers in a repetitive motion either singularly or simultaneously
  - Coordinate movements into smooth fluid motions including but not limited to eye/hand coordination activities and eye/hand/foot coordinated activities
  - Extend hand(s) and arm(s) in any direction (forward, downward, above shoulder level, etc.)
  
5. PHYSICAL ABILITY
  - Stand for extended periods of time.
  - Move from one area to another quickly, particularly for long distances and to be on the feet/mobile for 4-8 hours.
  - Maintain body equilibrium to prevent falling when walking, standing, or crouching on narrow, slippery and erratically moving surfaces exceeding what is required for ordinary locomotion and maintenance of body equilibrium.
  
6. ADAPTIVE ABILITY
  - Complete tasks or job functions within the required deadlines.
  - Complete required tasks/functions under stressful conditions.
  - Track and complete multiple tasks at the same time.
  - Perform independently with minimal supervision.
  - Interact appropriately with diverse personalities.

## NTCC | Cosmetology Program | Student Permits & Testing Information

### Student Permit:

In order for Cosmetology student's to legally practice Cosmetology services on clients in an educational lab setting, our licensing agency, Texas Dept. of Licensing & Regulation, requires students to have a student permit. Student's will fill out a permit application provided by the Cosmetology Department and pay a one-time fee of \$25 to TDLR for that permit. (Students will sit with instructors the week BEFORE their first class starts to get their student permit and pay the \$25 fee) The Cosmetology instructor will then enter the student's information into the TDLR online system which will generate a permit to be printed. Student's will then provide instructors with a photo which will be added to the permit to make it valid. Student permits will be displayed in public view on each student's station in the department for the duration of their participation in the program.

### Documentation:

Students ARE urged to let instructors know if they do not have a valid social security number when filling out their permit application because that warrants a different process for issuing a permit to a new Cosmetology student. Please understand, an SSN is not a requirement for a student permit, but if a student does not have an SSN, instructors will have to mail in the student's permit application to TDLR instead of doing the application online. Also, the \$25 required permit fee has to be mailed in with the permit in the form of a money order.

Once Cosmetology student's complete the 1000 required program hours needed to obtain a Texas Cosmetology Operator License, two state board examinations must be passed successfully with a 70 or above to obtain a Cosmetology Operator License. Cosmetology state board examinations are administered by PSI exams (a third-party company), at PSI exam testing centers, NOT BY NTCC INSTRUCTORS. These testing centers require each student/candidate to show valid government-issued identification, with their full name, matching on both their ID and their TDLR permit, (issued by the Cosmetology school) in order to take their examination. Student's failure to show proper ID will result in the student's forfeiting their exam fees and losing their exam "spot" on the given day. Student's will then have to re-schedule and re-pay for the exam. Proper identification includes a valid driver's license, state ID card, or passport (with a few exceptions). We ask that our students let instructors know if they will not be able to provide valid government-issued ID for testing so that details can be discussed concerning this matter ahead of time to save the student grief, time and money. All things of this nature are kept confidential and will be kept strictly between the student and the instructor of record. Instructors have experience in helping students determine what forms of ID will work for testing, so we urge all of our students to allow us this knowledge so that we may help them if possible.

Cosmetology State Board Exams – Current Pricing: Written Exam: \$55 | Practical Exam: \$76

State board examinations are scheduled and paid for by the student after they finish their Cosmetology course. This is just to notify prospective students of the current costs of Texas licensing exams.

It is the sincere hope of the NTCC Cosmetology Program that our students are confident that we take any and all student problems/concerns seriously and that we do our very best to encourage, counsel and advise students effectively when it comes to all issues including those mentioned above. This acknowledgement is simply to make sure students understand all of the requirements of the Cosmetology Program that will allow them to make an informed, thought-out decision before embarking on a career in Cosmetology.

## Acknowledgement of Class schedule & Attendance Policy

The Cosmetology Program schedule is as follows:

Fall Semester: Monday-Thursday, 7:30am – 12:30pm (No lunch break)

Spring Semester: Monday-Thursday, 7:30am – 12:30pm (No lunch break)

Summer Semester: Monday-Thursday, 7:30am – 12:30pm (No lunch break)

Cosmetology Students are not allowed to miss more than 7 days in each semester without a doctor's note or documentation/explanation given to instructors. Due to the nature of the program being hours-based, students are on a "time clock" and monitored by Texas Dept. of Licensing and Regulation; a strict attendance policy is necessary and required.

## Acknowledgement of Hybrid Class Requirement & Policy

Texas Dept. of Licensing and Regulation requirement for the Cosmetology Operator Program is 1000 clocked hours in an accredited program. The NTCC Cosmetology program is a hybrid program with hybrid courses, meaning we are approved by TDLR to offer 25% of the required hours in an online format. Our students use an online interactive program called CIMA to do the online portion, and they must complete a certain amount online work per week. This work is done as homework, OUTSIDE of class time. It requires a compatible computer/laptop with reliable, fast internet. The online assignments and the online hours are a requirement for completion of this program.

## Northeast Texas Community College | Cosmetology Deposit & Refund Policy

- At the time of refund, if there is an amount owed on your NTCC account, the deposit will go toward those charges first. If there are any remaining funds, after the charges are paid, the remaining amount will be refunded to you.

## NOTICE OF POTENTIAL INELIGIBILITY FOR LICENSE

Texas law:

- restricts the issuance of occupational licenses based on a license applicant's criminal history; and
- authorizes the Texas Department of Licensing and Regulation (TDLR), in some cases, to consider a person convicted, even though the person was only on probation or community supervision without a conviction.

As an applicant/enrollee in an educational or training program that prepares individuals for issuance of an occupational license, I have been provided with notice by Northeast Texas Community College of the following:

- If I have been convicted of an offense or placed on probation, I might not be eligible for an occupational license issued by TDLR after I complete this educational or training program; TDLR's criminal history guidelines are available at [www.tdlr.texas.gov/crimconvict.htm](http://www.tdlr.texas.gov/crimconvict.htm) and include restrictions or guidelines TDLR uses to determine eligibility for an occupational license; and
- I have the right to request a criminal history evaluation letter from TDLR, which is explained in more detail at [www.tdlr.texas.gov/crimhistoryeval.htm](http://www.tdlr.texas.gov/crimhistoryeval.htm).

Section 53.152, Occupations Code, requires that notice be provided to each applicant and enrollee regardless of whether the applicant or enrollee has been convicted of an offense.

**REFUND AND ORDERED PAYMENTS.** State law requires TDLR to order an educational program provider to refund tuition, license application fees, and examination fees if:

- TDLR determines the provider failed to provide notice to me; and
- my license application was denied because of my criminal history.
