**Course Description:** An introduction to the fundamental terminology, concepts, theory, and application of two-dimensional design.

**Prerequisite(s):** none.

**Student Learning Outcomes:**

1. Identify and apply the elements of art and principles of two-dimensional design.
2. Employ discipline specific vocabulary in the evaluation of two-dimensional design problems.
3. Demonstrate creative skill in aesthetic problem solving within assigned parameters.
4. Demonstrate an appropriate level of professional practice, including safety, craft and presentation.

**Evaluation/Grading Policy:**

Projects will be graded within sever days of the due date using the rubrics at the end of this syllabus. The grade and completed rubric will be posted in the grade center in Blackboard. Any questions or concerns may be discussed during independent work time during the lab or during posted office hours.

The terminology exam is multiple choice. You will need a long scantron to take your exam. You must have the scantron sheet at the start of class on exam day.

You will receive a midterm grade posted in Blackboard in your MyGrades and in the Eagle portal.

The rubric results from your portfolio and traits such as timeliness, neatness, creativity, and attendance combine for a final grade in Design I. Your final grade will be posted in the Eagle portal.

**Grades are based on the following:**

- Three Projects: Acrylic Value Portrait, Design Notebook, and Final Artwork – 50%
- Syllabus Quiz and Design Terminology Exam – 25%
- Assignments and Exercises – 10%
- Discussion: Collaborate with Journalism Student, Critique Three Projects – 15%

**Required Instructional Materials:** There is no textbook for the Design I course, but you must purchase the design kit from the NTCC bookstore that has the handouts you must have for this class. You must have these supplies when you come to the second class. You can use the same supplies for your Drawing course in this Design course however, there are a few differences between the two supply lists. - ❖ Assorted brush set: (round and flat) & (large and small) suitable for acrylic painting
- ❖ 1" binder with the plastic sleeve on the front to hold your design cover
- ❖ 20 sheet protectors
- ❖ Marker set - do not buy the washable type - any inexpensive set with colors you like will do
- ❖ colored pencil set (your choice of set) Prismacolor is the best, but not necessary. ❖ Drawing pencils (your choice)
- ❖ Kneaded eraser
- ❖ Pencil sharpener
- ❖ Something to store your supplies in
- ❖ Printed design handouts

- design notebook with all exercises completed, graded by rubric
- self- portrait on canvas, graded by rubric; and
- final project on canvas, graded by rubric

**Communications:**

Microsoft Teams - You are required in this course to sign up for Microsoft Teams. Please follow the instructions in the Start Course Here folder. Microsoft Teams is a free app and should be downloaded on your cell phone. This will enable you to receive important class announcements and reminders from me via text message so that you will not miss any assignment changes or important updates. You can reply to these messages or send me texts through Microsoft Teams at any time during normal working hours.

Email communications must be from NTCC email; this is the **official communication** at NTCC. You must access your email daily through the myEagle portal. Announcements will be sent from the instructor via Blackboard.

When emailing me, please include your student ID number, first and last name as you are enrolled in the course, and what course you are in (this course is ARTS1311 Design I).

**Institutional/Course Policy:**

More than two absences are detrimental to your final grade, and you may lose a complete letter grade. More than four absences will result in a drop from the course or a failing grade. You must be punctual and attend class regularly. If you are marked late three times, that is equal to one absence. I will warn you in person. That means if you are late coming back from lunch, leave early, or show up late to class, you are marked late.

November 19, 2024 is the last day to withdraw with a "W".

Late assignments are not accepted. You must work within the deadlines set for each project. I will work with you to make sure this gets done. I will give you personal reminders in the class as to when a project is due. It is your responsibility to keep up with the due dates.

Wear comfortable clothing and shoes that are appropriate to working with equipment and supplies in the art lab. Floors may be wet and slippery.

Cell phone use: Turn the volume off on cell phones when in the classroom. Step outside if you must talk on the phone. One earbud at a time if you want to listen to your own music during independent working time . No earbuds when I am lecturing. No texting unless it is an emergency. No watching videos during independent working time unless they are videos for class.

Label your supplies and have ALL of them with you every Wednesday for class. You can leave them in the art lab if you prefer.

If you use a classroom tool, clean and sanitize it, and return it to the correct storage area.

You must sanitize your table and chair upon beginning the class and upon leaving the classroom at the end of class. You must sanitize any class supplies you use in the classroom upon receiving them and upon returning them.

Week 11	- Continue work on acrylic painting.
Week 12	- Review of design terminology in preparation for the terminology exam. - Continue work on mixed media artwork.

## **Appendix A Standard Grading Rubric for Art Studio Courses**

### **STANDARD GRADING RUBRIC FOR ART STUDIO COURSES Excellent Work (A) (90 - 100%)**

**Class Work:** student demonstrates outstanding skill, discernment and understanding of visual principles in accomplishing his or her work. The quality of work is excellent, and it is integrated with exceptional creativity.

**Participation:** student demonstrates through discussion, critique, and studio interaction outstanding ability to discuss and assess work, communicating how visual elements and strategies are used. The student demonstrates extensive use and understanding of concepts and terminology used in the discipline.

**Homework:** In the case of studio assigned homework (activity) the student completes the assignment in all aspects and creatively exploits possibilities within open-ended assignments. The work demonstrates skill, good judgment, and application of principles. In the case of written assignments, oral presentations, and research, the work/presentation/document, presents sound research and is well written and well presented.

### **Better Than Average Work (B) (80 - 89%)**

**Class Work:** student demonstrates moderate skill, discernment and understanding of visual principles in accomplishing his or her work. The quality of work is good, and it is integrated with some creativity.

**Participation:** student demonstrates through discussion, critique, and studio interaction a solid ability to discuss and assess work; communicating how visual elements and strategies are used. The student demonstrates competent use and understanding of concepts and terminology used in the discipline.

**Homework:** In the case of studio assigned homework (activity) the student completes the assignment and fulfills more than minimal requirements. The work demonstrates some skill, judgment, and application of principles. In the case of written assignments, oral presentations, and research, the work/ presentation/document, presents research and are reasonably well written and suitably presented.

### **Average Work (C) (70 - 79%)**

**Class Work:** Student demonstrates average skill, discernment and understanding of visual principles in accomplishing his or her work. The quality of work is modest, and it is moderately integrated.

**Participation:** student demonstrates through discussion, critique, and studio interaction an average ability to discuss and assess work, communicating how visual elements and strategies are used. Though the discussion and assessment of work is substantially complete, the communication of some visual elements and strategies is incomplete or missing. The student demonstrates a superficial rather than thorough understanding of concepts and terminology used in the discipline.

Homework: In the case of studio assigned homework (activity) the student completes most of the assignment and fulfills the minimum requirements. The work demonstrates modest skill, some judgment, and in parts, application of principles. In the case of written assignments, oral presentations, and research, the student makes a modest effort as evidenced by a satisfactory presentation/ document. Research may be incomplete, or lacking in organization.

**Below Average (D) (60 – 69%)**

Class Work: Student demonstrates lack of skill, discernment and understanding of visual principles in accomplishing his or her work. The quality of work submitted is less than acceptable, and it is poorly integrated.

Participation: student demonstrates through discussion, critique, and studio interaction a limited ability to discuss and assess work while communicating at a minimal or perfunctory level how the visual elements and strategies are used. Poor effort is made to relate an understanding of the art concepts and terminology used in the discipline.

Homework: In the case of studio assigned homework (activity) the student does not complete the assignment and fulfills only minimal requirements or submits work late. The work demonstrates a lack of skill, weak judgment, and little application of principles. In the case of written assignments, oral presentations, and research, the work/presentation/ document, presents faulty or negligible research and is not well written and/or presented.

**Failing (F) (40 – 59%)**

Class Work: Student fails to demonstrate skill or understanding of the issues involved. The quality of work submitted is insufficient and poorly integrated.

Participation: In discussion, critique, and studio interaction, the student states an opinion vaguely or does not assess the work and shows little to no evidence of an understanding of how visual elements and strategies are used. No effort is made to relate an understanding of concepts and terminology used in the discipline.

Homework: In the case of studio-assigned home work (activity) the student does not complete the assignment and does not fulfill the requirements. In the case of written assignments, oral presentations, and research, the work /presentation/ document, presents faulty or negligible research and is not well written and/or presented.
