# **Course Description:** 3 credit hours.

Topics for this course shall include: police authority; responsibilities; constitutional constraints; laws of arrest, search, and seizure; police liability.

Prerequisite(s): Successful completion of CRIJ 1301 Introduction to Criminal Justice

**Student Learning Outcomes:** Define police authority, explain the responsibilities and constitutional restraints as enumerated in the Texas Constitution, United States Constitution, and Bill of Rights. Outline the law of arrest and search and seizure developed through court decisions and describe the criminal and civil liability that result from improper acts and/or failure to act.
