Topics for this course shall include investigative theory; collection and preservation of evidence; sources of information; interview and interrogation; uses of forensic sciences; case and trial preparation.

Prerequisite(s): Successful completion of CRIJ 1301 Introduction to Criminal Justice

Student Learning Outcomes: Define the goals and objectives of criminal investigation; demonstrate ability to conduct proper crime scene investigations; illustrate the use of forensic science for various statutory offenses; organize the criminal case including field notes, reports, crime scene activities, and mandatory documentation of statutory warning.

The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education. Students to whom the rights have transferred are considered "eligible students."
