## **Course Description:**

4 credit hours.

Lecture/Lab/Clinical: Three hours of lecture and three hours of lab each week.

Survey course introducing chemistry. Topics reinforced in lecture and lab may include inorganic, organic, biochemistry, food/physiological chemistry, and environmental/consumer chemistry. Designed for non-science and allied health students. Successful completion of CHEM 1405 with a C or better allows the student to continue to CHEM 1407. May be taken to prepare for CHEM 1411 but cannot be substituted for CHEM 1411. Offered as dual credit only.

Note: Additional course fee(s) required.

**Prerequisite(s):** TSI complete.

## **Core Curriculum Purpose and Objectives:**

Through the core curriculum, students will gain a foundation of knowledge of human cultures and the physical and natural world; develop principles of personal and social responsibility for living in a diverse world; and advance intellectual and practical skills that are essential for all learning. Courses in the foundation area of life and physical sciences focus on describing, explaining, and predicting natural phenomena using the scientific method. Courses involve the understanding of interactions among natural phenomena and the implications of scientific principles on the physical world and on human experiences.

#### **Student Learning Outcomes:** Upon completion of this course, students will:

- 1. Define the fundamental properties of matter; classify matter, compounds, and chemical reactions; and identify trends in chemical and physical properties of the elements using the periodic table.
- 2. Write chemical formulas, write, and balance equations, use the rules of nomenclature to name chemical compounds, and define the types and characteristics of chemical reactions.
- 3. Demonstrate the ability to solve stoichiometric problems, to convert units of measure, and to demonstrate dimensional analysis skills.
- 4. Obtain and introductory understanding of quantum mechanics, apply the octet rule, draw resonance structures, and use VSEPR, valence bond, and molecular orbital theories.
- 5. Use the gas laws and basics of the Kinetic Molecular Theory to solve gas problems, determine the role of energy in chemical reactions, and solve thermochemistry problems.
- 6. Use basic apparatus and apply experimental methodologies used in the chemistry laboratory.
- 7. Demonstrate safe and proper handling of laboratory equipment and chemicals.
- 8. Conduct basic laboratory experiments with proper laboratory techniques.
- 9. Working in teams of two, demonstrate use of critical thinking and scientific problem-solving skills in the laboratory including the ability to carry out experiments in a safe and efficient manner.

These learning outcomes will be assessed throughout the course and on the final exam. Teamwork and Communication Skills will be assessed through laboratory reports.

Grades are posted to Blackboard during the term. The student should email the instructor for any questions or concerns about grades. Graded work is typically return within a week. Overall grades will be rounded according to standard rounding rules (i.e., an 89.4 = 89 but an 89.5 = 90), but grades must be earned (not "bumped up" to a higher letter grade when it was not earned).

#### **Required Instructional Materials:**

**Inclusive Access:** NTCC has negotiated with the publisher to obtain a discounted price for the lecture course materials. The student's eBook and Mastering Chemistry access code are included in the price of tuition and will be available on the first day of class through a link in Blackboard - Start Here folder. The materials are required for this class and essential for student success. Optional loose-leaf print copies of the textbook, in addition to the electronic access, are available in the College Store for purchase at a discounted price. Through Sept. 15, 2024, the student may opt out of purchasing these materials from the College Store. If a student chooses to opt out, NTCC will issue a refund for the Inclusive Access, and the student will be responsible for purchasing the eBook (or print book) and Mastering Chemistry access code from another vendor.

**Communications:** NTCC email is the official form of communication used by the college. It is also the most important method of direct communication between dual credit students and the NTCC instructor. Course announcements will be made through Blackboard and copied to the student's NTCC email account. To schedule a virtual TEAMS or in-person appointment with the instructor outside of office hours, the student should email the instructor. Students may email anytime, even after hours and weekends. The instructor typically responds to email messages within 24 hours.

#### **Course Structure and Overview:**

This course is a dual credit course which allows a student to satisfy high school graduation requirements while also earning four college credits at NTCC. Dual credit students will experience the traditional face-to-face class directed by their high school teacher. At the same time, these students will have online instruction directed by an NTCC instructor. In this context the term "lecture" applies to both settings. Online instruction is provided through reading assignments, instructor-developed lessons and tutorials, and third-party resources. Laboratory experiments will be completed face-to-face with the high school teacher. All of these are designed to support and enrich a student's understanding of the topics covered. We cover approximately one chapter per week. Online instruction will utilize Blackboard, a learning management system utilized by NTCC as well as many other colleges and universities. The eBook, *Chemistry, the Central Science*, and the online homework system, *Mastering Chemistry*, are essential to this course.

Tests & Quizzes — Three tests covering about three chapters each will be given on the scheduled Thursdays. Questions could come from assigned readings, lecture, homework, and quizzes; the format may include multiple choice, short answer, and problem-solving questions. There is a Mastering Chemistry review quiz for each chapter, due the night before the test that covers that chapter. The student may complete the quiz any time before the due date - right after completing the chapter or any time before the due date. These quizzes will be averaged into the test average. Students will be allowed to use instructor-provided reference information such as periodic tables and equations during the exams and quizzes, as well as a non-programmable calculator; sharing calculators is not allowed. The test average counts 40% of the overall grade.

A comprehensive Final Exam will be given on Wednesday, December 11, 2024, during finals week. Like the chapter tests, it will be taken in person at the high school, and students will be allowed to use a non-programmable calculator and instructor-provided reference material. The format of the final exam will be announced in class the week before the final exam. It counts 15% of the grade.

**Laboratory Assignments** - Work in the laboratory is central to the topic of chemistry. Each chapter has an experiment to reinforce topics covered in lecture and help the student apply knowledge to real world problems. Experimental work can only take place in person in the chemical laboratory, so it is imperative that students make arrangements with their instructor to make up any missed lab work. Labs are typically due at the end of class of Fridays. Lab assignments count 25% of the overall grade.

Mastering Chemistry & Other Assignments – This category includes Mastering Chemistry assignments and anything assigned by the instructor that does not fit into another category. There is a Mastering Chemistry Homework Assignment for most chapter sections; they are generally due midnight Monday of the week after studying the chapter. Blackboard has links for each assignment. They include tutorials and activities for key topics as well as practice problems and questions to help you reach mastery. Students should NOT wait until the night before the due date to start these assignments but rather should pace themselves. The course timeline below notes the number of sections in each chapter to aid in pacing.

Because each chapter builds on the previous chapter in chemistry, it is important to correct any misconceptions quickly. A student scoring lower than 70 on a Mastering Chemistry assignment will automatically be assigned an Adaptive Follow-up assignment targeted to the particular areas of misunderstanding on that assignment. This gives the student another chance to learn, review, and answer questions correctly, and to add up to ten points extra credit to the original homework assignment.

More information for registering for Mastering Chemistry and its use can be found in Blackboard. Assignments count 20% of the overall grade.

### **Institutional/Course Policy:**

#### **Attendance:**

Regular and punctual attendance at all scheduled classes is expected for all students. Attendance is necessary for successful completion of course work. Students are expected to communicate with the instructor regarding any absence. The student is responsible for initiating procedures for make-up work. All course work missed, regardless of cause, is to be completed to the satisfaction of the instructor. Attendance in the online portion is counted by submitting assignments on time in Blackboard.

**Student responsibilities**: Students should recognize that the lecture portion of this course is online. The student will study the lecture material in Blackboard on his own time.

- ✓ The student will do the same amount of work as if attending in-person.
- ✓ The student will need self-discipline to complete assignments by the due date.
- ✓ The student will need to check NTCC email every day.

Late work: Chemistry is a sequential course; each topic builds on previously taught topics. Therefore, it is critical to meet the assignment deadlines each week. Students have access to most instructional material from the first day of class and may work ahead. Any assignment, lab or test that is not completed by the assigned date (or alternate date with instructor approval) earns a grade of zero. Nevertheless, late work is accepted up to one day late for labs and Mastering Chemistry assignments with a 10% penalty. The late penalty may be waived if the student has an excused absence and informs the instructor before the due date. Tests must be taken on the scheduled day unless prior arrangements have been made with the instructor before the exam. The review quizzes may be taken late only if the student made prior arrangements to take the corresponding test late. The final exam must be taken at the scheduled time.

Withdrawing: There is a procedure for withdrawing from this course; the student should not simply quit attending. If the student determines that it is in his best interest to withdraw from this course, the student must contact the Registrar's office to initiate the withdrawal process (903-434-8139 or <a href="mailto:bgooding@ntcc.edu">bgooding@ntcc.edu</a>). The last day to drop this course with a grade of W is Tuesday, November 19, 2024. Failure to officially withdraw by this date will result in the student receiving a grade of F.
