# This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

**Course Description:** In-depth study and applications of polynomial, rational, radical, exponential, and logarithmic functions, and systems of equations using matrices. Additional topics such as sequences, series, probability, and conics may be included. Three hours credit.

Courses in the foundation area of mathematics focus on quantitative literacy in logic, patterns, and relationships. In addition, these courses involve the understanding of key mathematical concepts and the application of appropriate quantitative tools to everyday experience.

Course Structure and Overview: This is a 16-week embedded dual-credit course designed for students who are concurrently enrolled in both a high school algebra class and a college-level class. The course is managed with information and activities that are posted on the Blackboard Learning Management System. A typical class involves general participation by all students in discussions regarding mathematical principles and procedures being studied. Students are required to complete online homework in addition to in-class quizzes, projects, and exams. It is very important students keep up with course materials and assignments since this is a college-level course. Students are expected to complete all assignments by due dates.

**Communications:** The college's official means of communication is via your campus email address. I will use your campus email address, Mt Vernon email address, Blackboard, Google Classroom and MyMathLab to communicate with you outside of class. Make sure you keep your campus email cleaned out and below the limit so you can receive important messages.

**Institutional/Course Policy:** This is a dual-credit class held on the Mt Vernon campus.
