Course Description:

1 credit hour.

Lecture/Lab/Clinical: One hundred twenty-eight hours of clinical in an emergency department, labor and delivery, and mobile intensive care unit.

Prerequisite(s): EMSP 1501, EMSP 1164

Co-requisite(s): EMSP 1338, EMSP 1356, EMSP 2306, EMSP 2444, EMSP 2330

Instruction providing detailed education, training and work-based experience, and direct patient/client care, generally at a clinical site. Specific detailed learning objectives are developed for each course by the faculty. On-site clinical instruction, supervision, evaluation, and placement is the responsibility of the College faculty. Clinical experiences are unpaid external learning experiences.

Student Learning Outcomes:

- 1. Integrate pathophysiological assessment findings to formulate a field impression of medical and trauma patients.
- 2. Integrate pathophysiological assessment findings to formulate a field impression of special population patients.
- 3. Integrate pathophysiological assessment findings to formulate a field impression and treatment plan for emergency patients in the prehospital setting

Evaluation/Grading Policy: Grading of the Domain Sections

All EMS courses have a cognitive and affective grading domain. A passing grade must be achieved in all of those domains in order to pass the course. If both domains are passed, the letter grade will be assigned based on the performance in both domains.
