**Evaluation/Grading Policy:** The online assignments are split between HUMA 1301 and MUSI 1306. See Blackboard for the online components. The Midterm and Final exams will cover the material in the course(s) in which you are enrolled. You only need to complete the online activities for the course(s) in which you are enrolled. The live performance final, artistic reaction pieces, and research project with poster are required regardless of whether you are enrolled in only one course or both courses. You will need to attend two artistic functions, whether you are enrolled in one course or both.

#### Grade Breakdown (same for both HUMA 1301 and MUSI 1306):

- (10%) Live Performance Final Exam
- (10%) Artistic Reaction Piece 1 (live music, art museum, etc.)
- (10%) Artistic Reaction Piece 2 (live music, art museum, etc.)
- (20%) Online assignments and activities
- (10%) Lab Work (guitar, piano, composition)
- (20%) In-Class Participation
- (20%) Research Presentation

For Honors Credit, all above grades become a percentage of 75 points (not 100)
