This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Course Description: 3 credit hours

Lecture/Lab/Clinical: Two hours lecture and four hours lab each week. Wiring methods for single family and multifamily dwellings. Includes load calculations, service entrance sizing, proper grounding techniques, and associated safety procedures. Note: Additional course fee(s) required.

Prerequisite(s): None

Student Learning Outcomes: Compute the circuit sizes needed for the installation of branch circuits, feeders, and service entrance conductors; explain the proper installation of wiring devices according to electrical codes; demonstrate grounding methods; install ground fault circuits; identify residential wiring methods; and demonstrate proper safety procedures.

Course Structure and Overview:
