Course Description:

3 credit hours. Lecture/Lab/Clinical: Three hours of lecture each week.

This course is an introduction to the fundamental principles of behavior. Special emphasis is placed on methods of research and critical thinking skills. This is a survey course and covers a variety of topics, theories and approaches to the scientific study of behavior and mental processes. PSYC 2301 is reading and writing intensive and is a college sophomore course.

Prerequisite(s): None

Student Learning Outcomes:

Upon successful completion of this course, students will:

- 1. Identify various research methods and their characteristics used in the scientific study of psychology.
- 2. Describe the historical influences and early schools of thought that shaped the field of psychology.
- 3. Describe some of the prominent perspectives and approaches used in the study of psychology.
- 4. Use terminology unique to the study of psychology.
- 5. Describe accepted approaches and standards in psychological assessment and evaluation.
- 6. Identify factors in physiological and psychological processes involved in human behavior.

Course Structure and Overview: Students will complete online study plans (readings) and quizzes for each chapter, 4 multiple-choice exams, an Experimental Design, 2 Summary Papers (summarizing select research articles), and a Reflections Paper. Self-Improvement opportunities and extra credit options are available throughout the semester to help students improve their overall grade in the course.

Communications: Students can expect my reply to any email correspondence within 12-24 hours, typically within a couple hours. *Reminder: NTCC email is the official form of communication used by the college.
