Course Structure and Overview:

This course is presented online using Blackboard Learning Management System. Students will be required to access Blackboard for <u>all</u> assignments. The course utilizes writing assignments as presented by the course textbook, and additional on-line instructional and project based components.

The instructor's policy is to grade what is submitted, and rarely allows assignment resubmissions. The time to ask is BEFORE an assignment is submitted. If a student is repeating this class, please note that there are often assignment changes made. It is required that students re-create each assignment. Significant grade reductions will occur when a student submits a previous semester's work.

BlackBoard will be used for assignment and exam submission.
