# This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Information relative to the delivery of the content contained in this syllabus is subject to change. Should that happen, the student will be notified.

**Course Description:** Continuation of Medical-Surgical Nursing I with application of the nursing process to the care of adult patients experiencing medical-surgical conditions in the health-illness continuum. Integrated concepts of nursing process nutrition pharmacology psychosocial needs and ethical legal issues are addressed in caring for clients with cardiovascular neurological integumentary musculoskeletal and hematological alterations. Includes a variety of health care settings.

**Credit hours:** 4 credit hours.

Lecture/Lab/Clinical: Four hours of coursework each week.

Prerequisites: Vocation Nursing Semester 1

Corequisite(s): The student must pass all vocational nursing semester 2 courses in order to be able to progress to vocational nursing semester 3.

### **Student Learning Outcomes/Course Level Outcomes:**

- 1. Implement the nursing process to holistically identify physical and psychosocial needs of patients experiencing medical-surgical disorders. (DEC LB.)
- 2. Develop a plan of care based on problem-solving and identified priorities for patients experiencing illness/disease, with consideration for pertinent cultural aspects. (DEC II.B.)
- 3. Use knowledge of diagnostic modalities and criteria (lab values, diagnostic imaging, etc) to assess and report patient status (DEC II.F.)
- 4. Demonstrate understanding of the vocational nurses' role on the interdisciplinary health care team (DEC II.A.)
- 5. Perform and document focused assessments for patients experiencing medical-surgical disorders to assist in identifying health status and monitoring changes (DEC II.C.)
- 6. Engage in activities that promote the profession of nursing (DEC LC.)

## **Evaluation/Grading Policy:**

The final Course Average is determined by the following:

Module Exams 70% of total grade

Seven module exams: 10% each (7x10=70% of total grade)

Comprehensive Final exam: 10% of total grade Pop Quizzes/Group Projects/Assignments 10% of total grade ATI Final Exam 10% of total grade

A minimum overall grade of "C" is required in all Academic and Nursing courses before using that course as a prerequisite for the next course in sequence. Academic courses (English, Ethics, etc.) typically work from a grade of 70 or higher for "C". In preparation for the State Board examination, the letter grade assigned to all Nursing courses shall be determined as follows:

A = 90 - 100

B = 80 - 89

C = 78 - 79

F = 77.9 and below

The average of the exam grades must be 78% or above to pass the course. Grades will not be rounded when calculating the average (77.5 - 77.9) is not rounded to 78).

Posting of grades: Exam grades will be posted within 72 hours after sitting for the exam and assignments within 7 calendar days from when the student turned in the assignment.

Late work will be graded, then ten points will be deducted for each day the assignment is late, up to three days. After the third day, the grade will remain a zero; however, all assignments are required to be completed in order to proceed to the next level of the program.
