Your lab grade will be based on participation, attendance, and being able to demonstrate proper techniques in artificial insemination, pregnancy diagnosis, and heat detection in cattle. Lab work may require suitable clothing for outdoor farm settings. Each student will be required to become BQA

certified. Additional lab times (TBA) will be based on the timing of artificial insemination in the college farm herd, pregnancy palpation needs, and field trips with the collaboration among students, farm manager, and professor. Adequate notices will be given to the students during scheduled class times of labs. If a student is not able to attend a lab or labs, additional assignments will be required.
