This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Course Description: Differentiation and integration of transcendental functions; parametric equations and polar coordinates; techniques of integration; sequences and series; improper integrals. Four hours credit.

Prerequisite(s): MATH 2513 or equivalent with a grade of “C” or better

Student Learning Outcomes:

2514.1 Use the concepts of definite integrals to solve problems involving area, volume, work, and other physical applications.

2514.2 Use substitution, integration by parts, trigonometric substitution, partial fractions, and tables of anti-derivatives to evaluate definite and indefinite integrals.

2514.3 Define an improper integral.

2514.4 Apply the concepts of limits, convergence, and divergence to evaluate some classes of improper integrals.

2514.5 Determine convergence or divergence of sequences and series.

2514.6 Use Taylor and MacLaurin series to represent functions.

2514.7 Use Taylor or MacLaurin series to integrate by conventional methods.

2514.8 Use the concept of polar coordinates to find areas, lengths of curves, and representation of conic sections.

2513.7 Articulate the relationship between derivatives and integrals using the Fundamental Theorem of Calculus.

Core Curriculum Purpose and Objectives:

Through the core curriculum, students will gain a foundation of knowledge of human cultures and the physical and natural world; develop principles of personal and social responsibility for living in a diverse world; and advance intellectual and practical skills that are essential for all learning.

Courses in the foundation area of mathematics focus on quantitative literacy in logic, patterns, and relationships. In addition, these courses involve the understanding of key mathematical concepts and the application of appropriate quantitative tools to everyday experience.

Minimum Technology Requirements:

Graphing Calculator is required. TI-84 is preferred, but other models may be approved by the instructor. Students must have daily access to a computer and broadband internet service to take this course. The computer should have Windows XP SP3 or later or MAC OS X10.3 or higher. You will need Office 2003 or higher. The operating system can be checked by right clicking on the “My Computer” icon on the home screen. The Word processing system can be checked by going to “Start” and clicking on “All Programs.” You may not be able to complete your assignments on your smartphone, a tablet, or a Chromebook. It is recommended that you use Safari, Google Chrome, or Firefox as a browser with the Blackboard LMS (learning management system).

Required Computer Literacy Skills:

- 1) Communicate via email;
- 2) Saving and reloading saved files;
- 3) Navigate Blackboard to access posted materials and WebAssign assignments.

Course Structure and Overview: This is a 16-week course where students are required to access graded activities on WebAssign via the Blackboard Learning Management System. A typical class involves general participation by all students in discussions involving mathematical principles and the algorithms to apply these principles. Students are required to complete online and in-class homework and over the course of the semester, four exams and a final exam. It is very important students keep up with course materials and assignments since this is a very fast-paced, intense course. Students are expected to attend class, read course textbook, and complete in-class and online assignments located in the Learning Management System, Blackboard by due dates.

Communications: Emails will be responded to within 25 hours during the week and 48 hours on the weekend.

Remind messages will be answered within a few hours during the day. Do not message after 10 p.m.

The college’s official means of communication is via your campus email address. Your campus email, Remind and Blackboard will be utilized to communicate with you outside of class. Make sure you keep your campus email cleaned out and below the limit so you can receive important messages.
