This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

### **Course Description:**

- An instructional program designed to integrate on-campus study with practical hands-on work experience in the biological sciences/life sciences. In conjunction with class seminars, the individual student will set specific goals and objectives in the study of living organisms and their systems.
- *Prerequisite(s):* instructor permission

### **COURSE Student Learning Outcomes:**

Upon successful completion of this course, students will:

- 1. Produce written rough and final drafts for possible student publication.
- 2. Participate in the process of journal publication.
- 3. Review pertinent journal articles.
- 4. Collect and document collections of living organisms
- 5. Create a lab notebook chronicling research conducted throughout the semester
- 6. Participate in research in the field (overnight and out-of-state) and/or in the laboratory setting.

### Lab Journal:

It is a requirement of this course to keep a Laboratory/Field Notebook. The notebook will be graded by Dr. Mac at the end of the semester. The notebook should be a <u>bound</u> composition notebook (minimum of 50 sheets with 5 x 5 quads), available at most bookstores or Walmart. It is worth a total of 100 pts.

### **Communications:**

- The major communication pathway between instructors and students in this course is face-toface during laboratory sessions and during office hours. Students are expected to ask questions and participate in discussions during laboratory sessions.
- NTCC email is the official form of communication used by the college. Email communications from non-NTCC email addresses will not be answered.
- Course announcements that occur outside of lab sessions will be announced via Blackboard's announcement feature. These will be cc'd to students via NTCC email.
- Students are expected to check Blackboard and their NTCC email accounts regularly.
- All grading policies and due dates for online homework assignments are listed in the online homework system and the course Blackboard page.

### **Institutional/Course Policy:**

• <u>Students are expected to be working in the lab or field for a minimum of three hours per week.</u>

• Students will schedule their lab time with the professor at the beginning of the semester to ensure regular laboratory or fieldwork. Additional times may be added or times may be adjusted as needed.

• <u>Attendance</u>

Attendance is mandatory for this course.

Attendance points may be lost for attitude, teamwork, and/or other interpersonal issues.

<u>Electronic Devices Policy</u>

 $\circ$  Wearing headphones in the lab is not allowed. Use of listening devices will earn the student a zero on work for that class session.

## • <u>Laboratory Experiments</u>

• Continuous work throughout the semester on one or all of our research projects.

• Laboratory Conduct and Attire

• Students are expected to adhere to the guidelines set forth in the "Commitment to Laboratory Safety Pledge" and in the safety video.

• Students must wear long pants covering their ankles—*leggings are unacceptable*, closed shoes (no exposed skin or sock), and shirts that cover their shoulders.

• Approved safety glasses/goggles are to be worn at all times in the lab. Students who wear corrective-vision glasses must have elastic-strap safety goggles that cover the entire glasses and seal against the forehead.

• Long hair should be pulled back. Failure to follow laboratory safety protocols could result in injury to yourself or others and will result in reduction of your laboratory grade.

• Students not dressed appropriately for lab will be asked to leave and will earn a grade of zero on that experiment.

• <u>Withdrawal Date (Drop Day)</u> **Thursday, April 10<sup>th</sup>** is the last day to withdraw from the course with a grade of "**W**". If you stop attending class and fail to officially withdraw, expect to earn a grade of "**F**" in the course.

• <u>Student Athletes</u>
