# This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

#### Course Description: 3 credit hours.

A survey of the development of British literature from the Anglo-Saxon period to the Eighteenth Century. Students will study works of prose, poetry, drama, and fiction in relation to their historical linguistic, and cultural contexts. Texts will be selected from a diverse group of authors and traditions.

**Prerequisite(s):** English Composition I is a pre-requisite for all 200-level literature courses.

## Student Learning Outcomes: Upon successful completion of this course, students will:

- 1. Identify key ideas, representative authors and works, significant historical or cultural events, and characteristic perspectives or attitudes expressed in the literature of different periods or regions.
- 2. Analyze literary works as expressions of individual or communal values within the social, political, cultural, or religious contexts of different literary periods.
- 3. Demonstrate knowledge of the development of characteristic forms or styles of expression during different historical periods or in different regions.
- 4. Articulate the aesthetic principles that guide the scope and variety of works in the arts and humanities.
- 5. Write research-based critical papers about the assigned readings in clear and grammatically correct prose, using various critical approaches to literature.

**Evaluation/Grading Policy:** Grades will be based on my evaluation of selected essays, literary projects, daily assignments, memory work, tests, and quizzes. Grades will be weighted as follows: Tests and essays, 30%; quizzes and research, 20%; peer reviews and presentations, 10%; Rough drafts and daily assignments, 15%; journal and reading questions, 25%.

#### **Course Structure and Overview:**

Daily class will involve lecture, reading, discussion, writing, tests, and quizzes, both announced and unannounced.
