Description of Graded Work

Exams: The exams will consist of two multiple-choice exams. Each exam will be between ten and twenty questions each.

Discussion Board Assignments: Will consist of the following:

- 1.) Discussion Questions (DQ): Individual student response to questions for each assignment. These questions will be based on the chapter readings. The discussion questions will consist of a minimum fifty (50) word response total for all questions NOT 50 words per question.
- 2.) Peer response (PR): Individual student response to a classmate's discussion questions. Since students will be responding to their classmates, the peer response will be posted in the same area as your discussion questions.
- 3.) Reading response (RR). The Reading response is a minimum one hundred (100) word response which can include:
 - a. A concise summary of chapter highlights (not a chapter outline) OR
 - b. Sharing how a topic in the chapter relates to your current or past work OR
 - c. Your take-away from the chapter (i.e. what key point was important to you and why).

Homework Assignments: This assignment is designed to help students apply the material for each assignment. These assignments will be representative of the type of problems that may be on each exam.

Review Questions: For each assignment there will be a set of review questions designed to ensure students understand the chapter readings. These questions will be representative of the types of questions that will be on each exam.

Homework Problems: For certain assignments there will be homework problems designed to ensure students understand the chapter concepts. These problems will be representative of the types of questions that will be on each exam.

Syllabus Acknowledgement Quiz: This is a short quiz that will test your understanding of the syllabus. This quiz is worth 100 Points towards your grade. Upon completion of this quiz, you will be certified as attending this class. Class certification is required by NTCC and not being certified in a class can negatively impact your enrollment status with the college.

Student Biography: The purpose of the biography is to introduce yourself to the class. Just tell us about your career interests and academic goals, whether you are a full or part time student, and if you are already working in the logistics field. A biography is posted that you can use as a guide.

This is an online class without any in person meeting. All work will be contained in the Learning Management System, (Blackboard) course and Cengage Mind Tap (Publisher Material).

Students are expected to complete all the readings of the required e-book chapters, watch videos and complete the online chapter activities. You will see that the course is divided into 8 weeks in the Blackboard portion. Each week you will be expected to complete certain online assignments for the chapters found in Mind Tap. This course requires daily computer and internet access. You should expect to spend no less than 3-6 hours a week in this course.
