Course Description: 3 credit hours - Two hours of lecture and three hours of lab each week. Major agricultural disease and pest agents will be studied, focusing on the biology of the pests to include life cycle, structure, and typical hosts. Management and control utilizing least toxic methods will be emphasized, the foundation of which is healthy soils. (spring)

After the completion of this course the student should be able to:

1. Define Integrated Pest Management or IPM and demonstrate the proper use of it on agriculture enterprises.

2. Define and describe beneficial insects and how to manage and attract them for farm and garden pest control.

3. Describe how to control destructive pests organically and chemically.

4. Define economic threshold as it relates to IPM.

Tests/Exams: There will be 2 exams accounting for 60% of your overall grade. Exams will be multiple-choice, true/false, fill in the blank, short answer and essays developed from the textbook, labs, quizzes and lectures. Exams will be taken during class, should you require additional times you are required to notify instructor ahead of the exam time. The following dates are subject to change, students will be notified in advance. Only excused absences will be allowed for you to make-up an exam. An appointment must be made to take the make-up exam. Failure to take the make-up exam will result in a grade of zero.

Lab Participation: Students are required to participate in both classroom and lab activities. Students will be required to travel locally for some of the labs. Students will be expected to arrive on time and behave in a professional manner. Students are also required to dress appropriately for labs; this includes closed toed shoes, safety glasses (when required), and appropriate dress for working outdoors.

Assignments: Due dates for assignments will be provided by the instructor in class. Assignments will receive 10 points off each day they are late up to 3 days. After the 3rd day, a grade of zero will result.

Course Structure and Overview: This course will be held on Tuesday and Thursday in AGC117 from 11:00-12:20 for 8 weeks only beginning March 21, 2022. The course will consist of classroom lectures using multimedia presentations as well as classroom discussions. All lecture materials will be in the blackboard section for this course. You will be **required** to view the lecture materials outside of class time due to the hybrid structure of this course. Labs will consist of hands on learning, demonstrations, online assignments and field trips. The lab portions of the course will be conducted as assigned on The Sustainable Market Farm in the areas consistent with course requirements.
